Outstanding Accounts

The board reviewed the outstanding account balances, which total over \$10,000. The Board has agreed to continue to file liens against those accounts that have a balance owed of over \$300.00 and no payment for over two months.

On the account on Melton Lane, the Board will wait until it reaches about \$10,000 in arrears and then discuss a utility foreclosure. We have already taken this account to court and won a settlement but have been unable to collect at this point.
